Call to Order: J Christensen called the meeting to order at 11:30 am

Approval of Change in Agenda: Motion (O Clark moved, E Cross second) to move agenda items of Seminar Topics to first item addressed and the addition of UW-Minds presentation as second item. Unanimous approval.

Seminar Topics from Superior School District for EdL: These are offered each year in cooperation with the school district. The question was raised whether topics must be approved by the Council each year? If a topic is approved once, does it need to be approved again the next time offered? Seminars may not be used toward a degree, but are often used for professional development or Continuing Education Units. K Berry moved: Topics for Seminars offered through Continuing Education be managed by the individual departments. O Clark second. Unanimous approval.

Minds@ UW—Kristen Lindquist: This will be available in fall 2010 for digital publication of theses, pending Council approval. There is currently no charge to students to use this service. Current binding expenses are approximately \$140.00. Digital publication would allow greater exposure and access of student's work. Kristen outlined the process for submission. She is currently testing some theses submissions. Council members are asked to consult with their departments and return in the fall to make a decision on approval.

Meeting Minutes: Motion (O Clark moved, S Loonsk second) to approve the March 23, 2010 minutes. K Berry requested adding "if necessary" to the section of assignment of grad special advisors by program coordinators. Motion approved unanimously with the addition. Motion (K Berry moved O Clark second) to approve the April 20, 2010 All Graduate Faculty minutes. Discussion followed regarding recording attendance of those who attended outside the actual meeting period. Unanimous approval with inclusion of "Other faculty and administrators attended outside of actual meeting time."

Chair Announcements:

- A secretary for 2010-2011 has not been selected. This will be revisited in the fall.
- Grad Charter review will begin in the fall. Specific meetings or time limits for this will be considered
- 2010-2011 meetings will take place on the 1st and 3rd Tuesdays beginning Sept 7th from noon to 1:00pm.

Discussion: Like the new process of department approval, submission of current vita to Dean of Faculties, then forwarded to the Council for final approval. Grad office is maintaining a spreadsheet of current faculty and is moving toward keeping digital copies of vita. Limited grad faculty are approved annually and should submit updated vita annually.
