In the Educational Attainment Strategy Plan: UW-Superior document, Jane encouraged committee members to review this draft strategy to become familiar with the overarching strategies discussed as necessary resources to increase recruitment and retention. The proposed costs are identified in the right column. Overarching themes include: recruitment of nonresidents, CRM purchase, scholarship opportunities, distance learning development, staffing (faculty, academic staff and support staff).

Assurance was given that from 3/22/10 and onward, the members of the Student Retention and Enrollment Committee will be emailed documents 3 days prior to the meeting with a number and a date on each document; this will give the members time to review and analyze the materials before the meeting.
