| <b>Apr 10<sup>th</sup></b> | Several individuals were issued citations in Hawkes Hall after officers responded to a noise complaint. A male student was cited for 4 <sup>th</sup> offense Underage Drinking and is subject to a possible fine amount of \$767.50. Two male students were both cited for 1 <sup>st</sup> offense Underage Drinking and are subject to a possible fine amount of \$263.50. Two male students were both cited for Resisting/Obstructing Police Officer and are subject to a possible fine amount of \$452.50. |
| <b>Apr 12<sup>th</sup></b> | In Curran/McNeill Halls, a female student was cited for 1 <sup>st</sup> offense Underage Drinking and is subject to a possible fine amount of \$263.50.   |
| <b>Apr 14<sup>th</sup></b> | In Curran/ McNeill Halls, a male student was cited for 5 <sup>th</sup> offense Underage Drinking and is subject to a possible fine amount of \$767.50. As a result of the same call a male student was cited for 1 <sup>st</sup> offense Underage Drinking which carries a possible fine amount of \$263.50.
