## INCIDENT SUMMARY REPORT

### April 1 - 30, 2018

<b>Apr 2<sup>nd</sup></b>	A student reported he was sitting in his truck in lot# 11 when a car backed into him and left the scene. He provided a description of the suspect vehicle and said his truck only received very minor damage. Two days later the student observed the car again and provided the license number to Public Safety. The vehicle owner was contacted and she admitted backing into a truck but didn't think it was hard enough to cause any damage. The reporting party was provided with her information and he declined to press charges.
<b>Apr 8<sup>th</sup></b>	Officers responded to a report of possible underage drinking on the 1 <sup>st</sup> floor of Curran/McNeill Halls. Seven individuals were subsequently cited for Underage Drinking, first offense, and are each subject to a possible fine amount of \$263.50.
<b>Apr 14<sup>th</sup></b>	A visitor to campus reported her car had been damaged while it was parked in lot #7 possibly by a hit/run vehicle.
<b>Apr 21<sup>st</sup></b>	An SSC Custodian reported that a soap dispenser had been vandalized in 3 <sup>rd</sup> floor Crownhart restroom.
<b>Apr 24<sup>th</sup></b>	An SSC Custodian reported that shower doors and a wall had been vandalized in the same Crownhart 3 <sup>rd</sup> floor restroom.
<b>Apr 25<sup>th</sup></b>	A student reported that her vehicle had been struck by an unknown vehicle while it was parked overnight in lot #3A.
<b>Apr27th</b>	A student residing in Curran/McNeill Halls reported that after learning his checking account was overdrawn, he discovered that two checks had been stolen from the back of his checkbook. Only one had been cashed as of the time of the report and the matter remains under investigation.
	An unlocked bicycle was reported to have been stolen from the Hawkes Hall bike rack area.
