CRIME REPORTS
August 1 - 31, 2011

- Aug 01: A male student was arrested in Hawkes Hall for Harassment under State Statute 947.013 and lodged at the Douglas County Jail.
- Aug 09: The Superior Police Department arrested an adult male for the theft of a garden hose and sprinkler head from the Swenson Hall area. The hose and sprinkler head were returned to the university.
- Aug 22: An adult male was reported to be causing a disturbance near a Soccer Team practice. Campus Safety officers removed the individual from the area and warned him he could be arrested if he returned. He stated that he understood and was released.
- Aug 25: A student reported that his unlocked bicycle had apparently been stolen from the bike rack outside Curran/McNeill/Ostrander Halls.
- Aug 26: A male student was cited for Underage Drinking – first offense, and is subject to a possible fine amount of \$263.50.
- Aug 27: A student reported that someone had apparently hacked into his Facebook account and posted many inappropriate items. This is being investigated further by Campus Safety and the Superior Police Department Computer Forensics Unit.
- Aug 28: A male student was cited for Underage Drinking – second offense within one year, and is subject to a possible fine amount of \$389.50.
