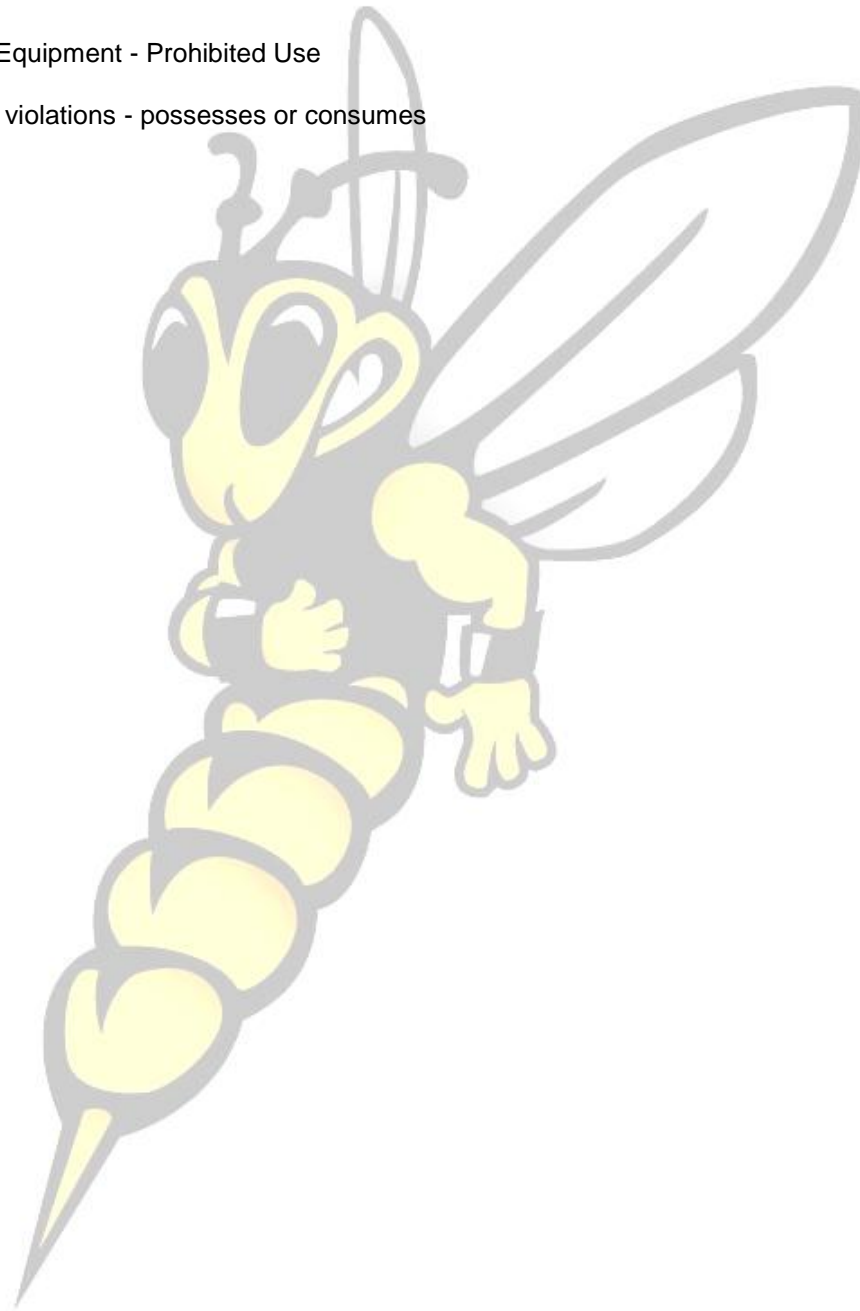

Aug 20th:

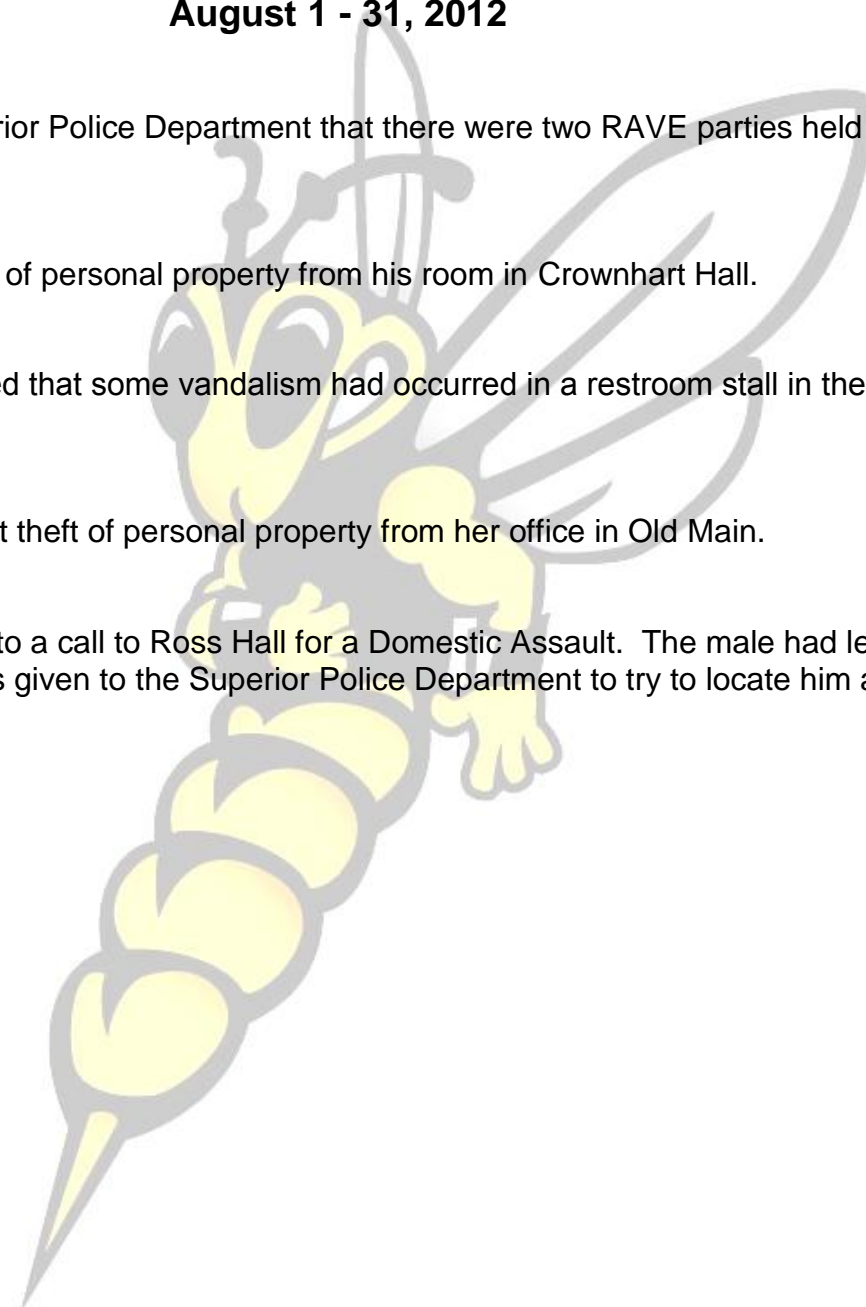
A Resident Life Staff Member reported that some vandalism had occurred in a restroom stall in the Ostrander Hall's basement.
