INCIDENT SUMMARY REPORT August 1 - 31, 2013

- Aug 6th:** A student reported that her vehicle had been hit by another vehicle sometime in the previous two weeks while it was parked in Lot #3B. A review of video surveillance recordings over that time period identified a possible suspect vehicle. The vehicle owner, another student on campus, was located and he confessed to causing the damage. The victim declined to pursue charges after the suspect agreed to pay for damages.
- Aug 13th:** A student reported that some of her art supplies were stolen from the drawing room #3118 in the Holden Fine Arts Building.
- Aug 23rd:** A student reported that apparently someone had made unforced entry into his locked room in Hawkes Hall and stolen a personal item.
- Aug 26th:** A student reported that a friend that was visiting him in Hawkes Hall had accidentally broken a window next to the doorway into the kitchen on the second floor.
- Aug 28th:** In Hawkes Hall, a female student was cited for Underage Drinking – first offense, and is subject to a possible fine amount of \$263.50.
