**INCIDENT SUMMARY REPORT
August 1 - 31, 2014**

Aug 22	A local RV dealer was displaying at Wessman Arena when one of their employees found a person sleeping inside one of the travel trailers. The male left on foot but the employee was unable to provide a good description of the person. Campus Safety and officers from the Superior Police Squads searched the area but were unable to locate the individual. It was later discovered that attempts had been made to steal TV's, power cords, and a radio from several of the trailer units. It did not appear that anything was actually taken and the matter remains under investigation.
Aug 26th	In Curran-McNeill Halls, a female student was cited for Possession of Marijuana and Underage Drinking-first offense. She is subject to possible fine amounts of \$389.50 and \$263.50 for each offense.
