**INCIDENT SUMMARY REPORT
August 1 - 31, 2017**

Aug 8th	At approximately 10:20pm officers responded to the Ross/Hawkes Hall area on a report of two suspicious males. Due to recent bicycle thefts from the halls, the officers began to search the area. A short time later the officers observed two individuals near the Superior High School and requested assistance from the Superior Police Department. SPD took over the investigation and subsequently arrested one of the males on a felony warrant out of Minnesota. The two were found to be in the possession of burglary tools and radios and it's suspected they were possibly about to break into the school or a construction trailer. Officers learned the two had arrived on bicycles and parked them by Ross Hall before walking over to the high school. One of those bikes was later verified as having been stolen out of Minneapolis last year. In addition some credit cards and personal IDs were found lying in the grass by Ross Hall near where the two males had been observed earlier. It was learned these had been stolen during a residential burglary in Duluth the day before. Public Safety assisted the other agencies with follow up.
Aug 10th	A double headed parking meter was reported missing from Lot 12 and is presumed to have been stolen.
Aug 30th	Public Safety responded to a report of a strong odor of marijuana on the 3 rd floor in Curran/McNeill Halls. After identifying the room the odor was coming from, a male resident was cited for possession of Marijuana and is subject to a possible fine amount of \$389.50.
