**INCIDENT SUMMARY REPORT
December 1 - 31, 2014**

Dec 5th	Campus Safety responded to Curran-McNeill Halls on a report of a possible marijuana odor. One adult male was subsequently cited for Possession of Marijuana and Possession of Drug Paraphernalia and is subject to a possible fine amount of \$389.50 and \$326.50 respectively.
