**INCIDENT SUMMARY REPORT
February 1 - 28, 2015**

Feb 5th:	Called to Curran-McNeill Halls for an odor of fresh marijuana coming from a room on the first floor. Upon investigation one adult male resident was cited for possession of Marijuana and Possession of Drug Paraphernalia and is subject to a possible fine amount of \$389.50 and \$326.50 respectively.
Feb 6th:	A complaint of an intoxicated female in the area of Ross Hall was received. Upon investigation one adult female resident was found to be intoxicated and was cited for Underage Drinking – first offense, and is subject to a possible fine amount of \$263.50.
Feb 15th:	Called to Curran-McNeill Halls for an Underage drinking incident. Upon investigation five adults were cited for Underage Drinking – first offense. One adult female cited was not a resident. Two adult female residents and two adult male residents. All are subject to a possible fine amount of \$263.50 each.
