| Feb 1st | A male student was cited In Hawkes Hall for Possession of Marijuana and Possession of Drug Paraphernalia. The charges carry possible fine amounts of \$389.50 and \$326.50. |
| Feb 2nd | A male student was cited in Ross Hall for Possession of Marijuana and Possession of Drug Paraphernalia. The charges carry possible fine amounts of \$389.50 and \$326.50. |
| Feb 11th | Two male students were cited In Ross Hall for Underage Drinking-first offense and are subject to possible fine amounts of \$263.50 each. A male student reported to a Faculty member that he had been threatened by another student at the Yellowjacket Union. No charges were pressed and the matter was handled by the Student Conduct office. |
| Feb 12th | A male student was cited In Curran/McNeill Halls for Possession of Marijuana which carries a possible fine amount of \$389.50. |
| Feb 13th | An SSC employee reported that two 50 foot extension cords had apparently been stolen from outside of Erlanson Hall. |
| Feb 20th | A male student reported that his vehicle had been struck by another vehicle while it was parked in lot #2. |
| Feb 27th | A Campus Security Authority filed a report concerning a student victim's disclosure of being sexually assaulted by another student in February of last year in a residence hall room. The victim chose not to pursue criminal charges and the matter was investigated through the Title IX process. |

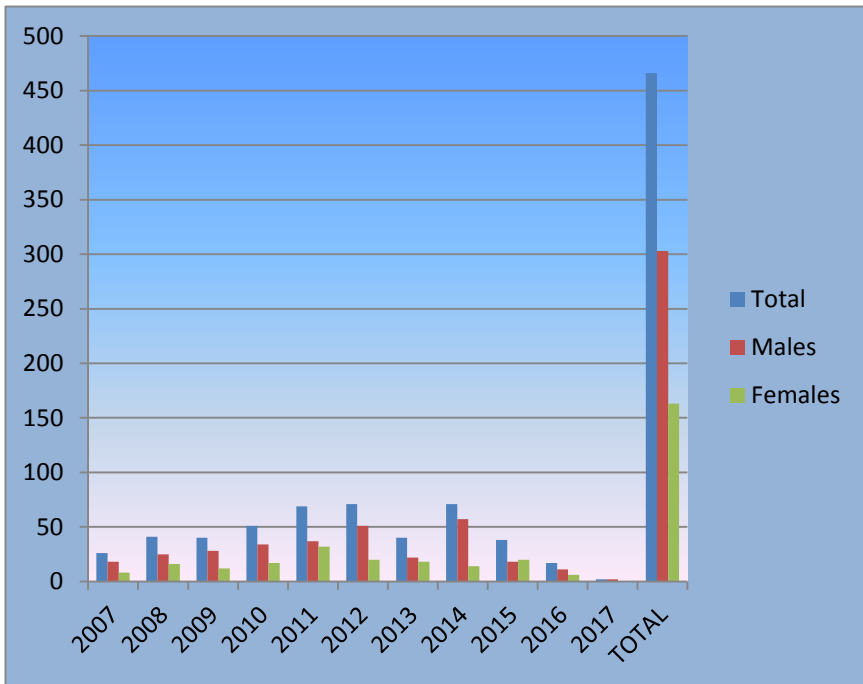
