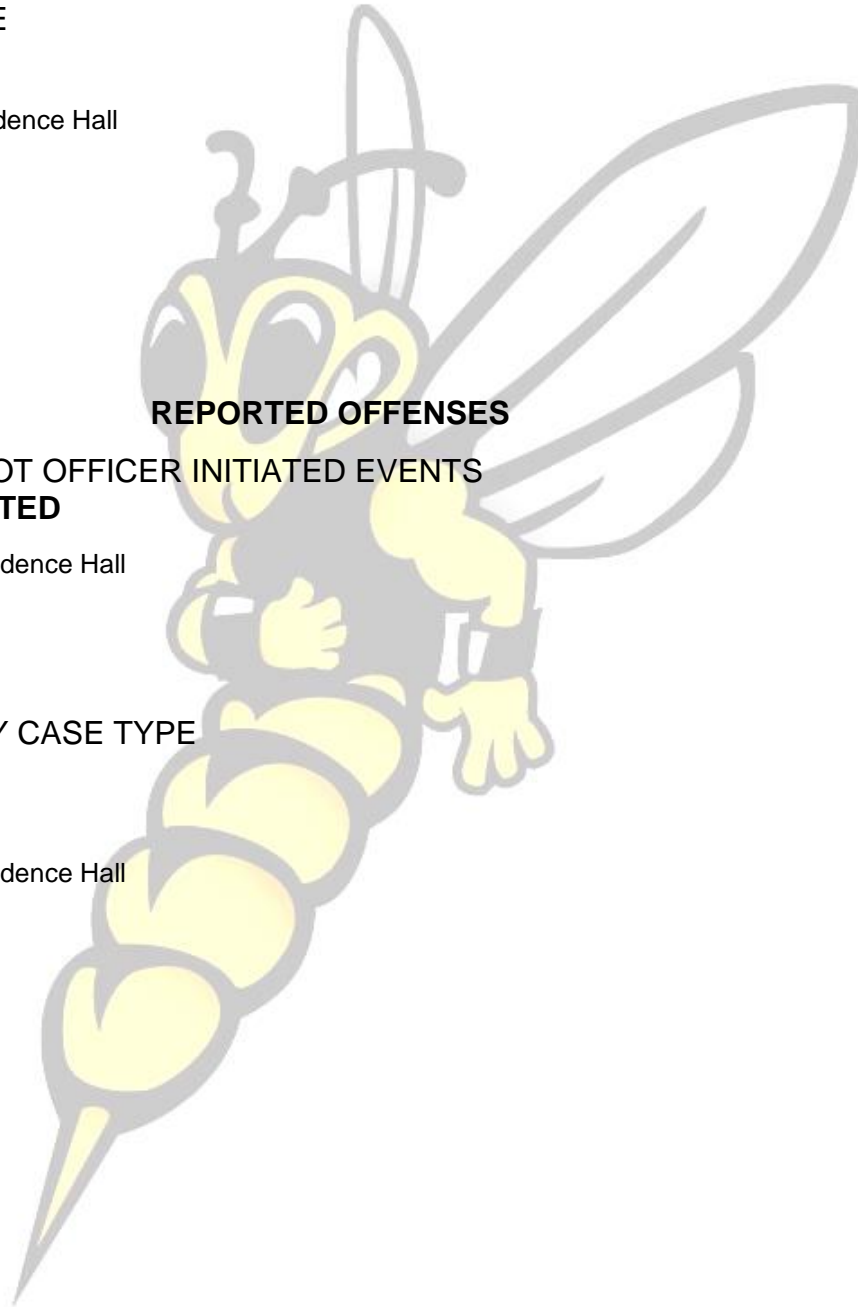

July 26th:

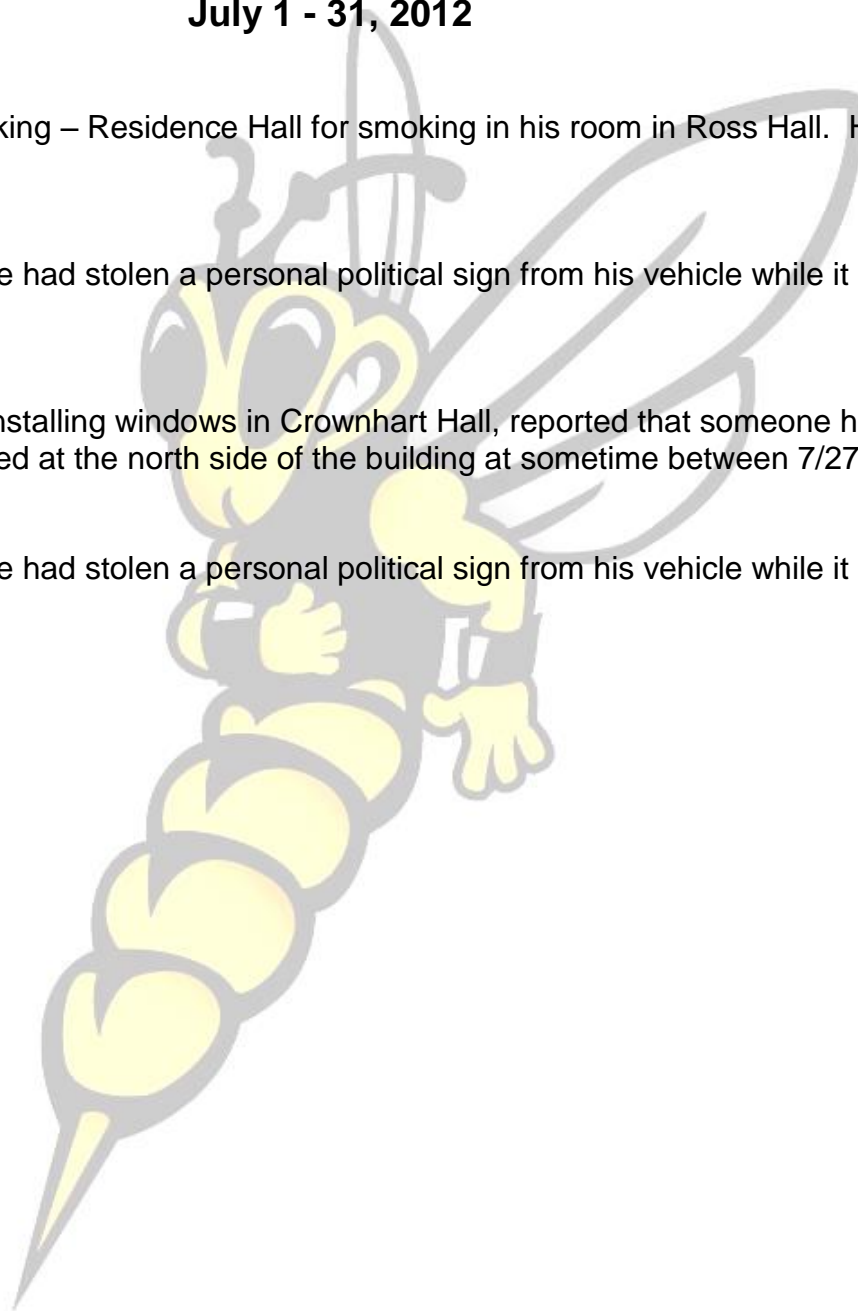
A staff member reported that someone had stolen a personal political sign from his vehicle while it was parked in lot #2 on 07/24/2012.
