| July 11 | Campus Safety responded to a report of a possible disturbance in a kitchen area in Hawkes Hall. One person started an argument with several others over kitchen rules. Some punches were thrown but apparently nobody was injured. None of the individuals wanted to press charges. The matter was referred for internal discipline review. |
| July 18th | A student reported that two cards were allegedly stolen from his wallet in his locked room in Hawkes Hall while he was sleeping. He later reported he found one of the cards in his room. |
| July 30th | A student worker reported that a cutting tool was stolen from the area where he and three other students were doing landscaping work by Ross/Hawkes Halls. They had noticed another student hanging around the area shortly before the tool went missing. The complainant said a short time later he saw this person again and accused him of taking it. The suspect said he would bring it back and left but did not return. The suspect was located later by Campus Safety and was issued a citation for theft. |

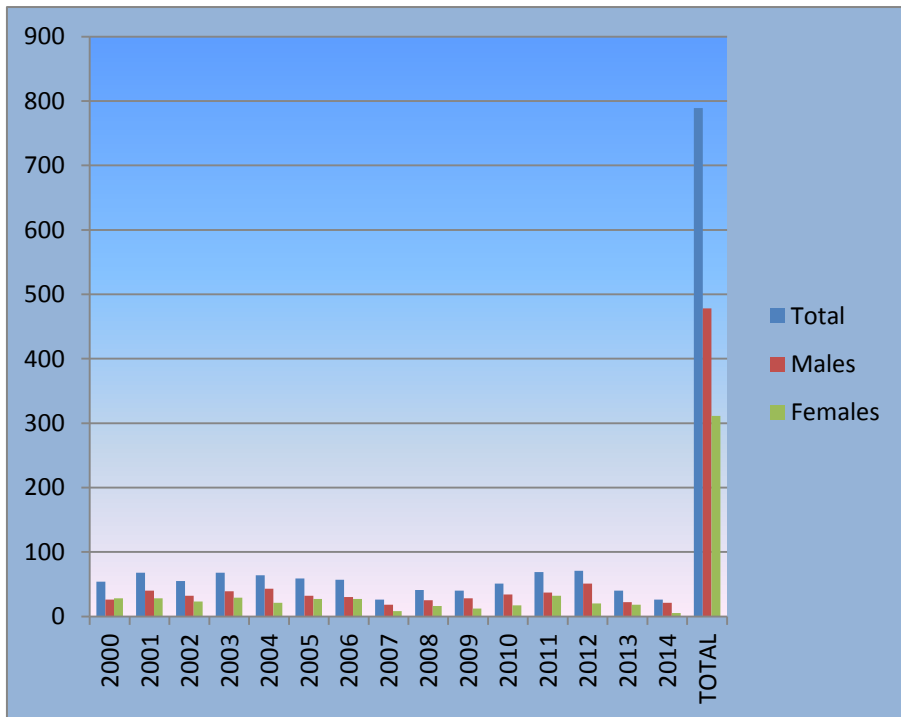
