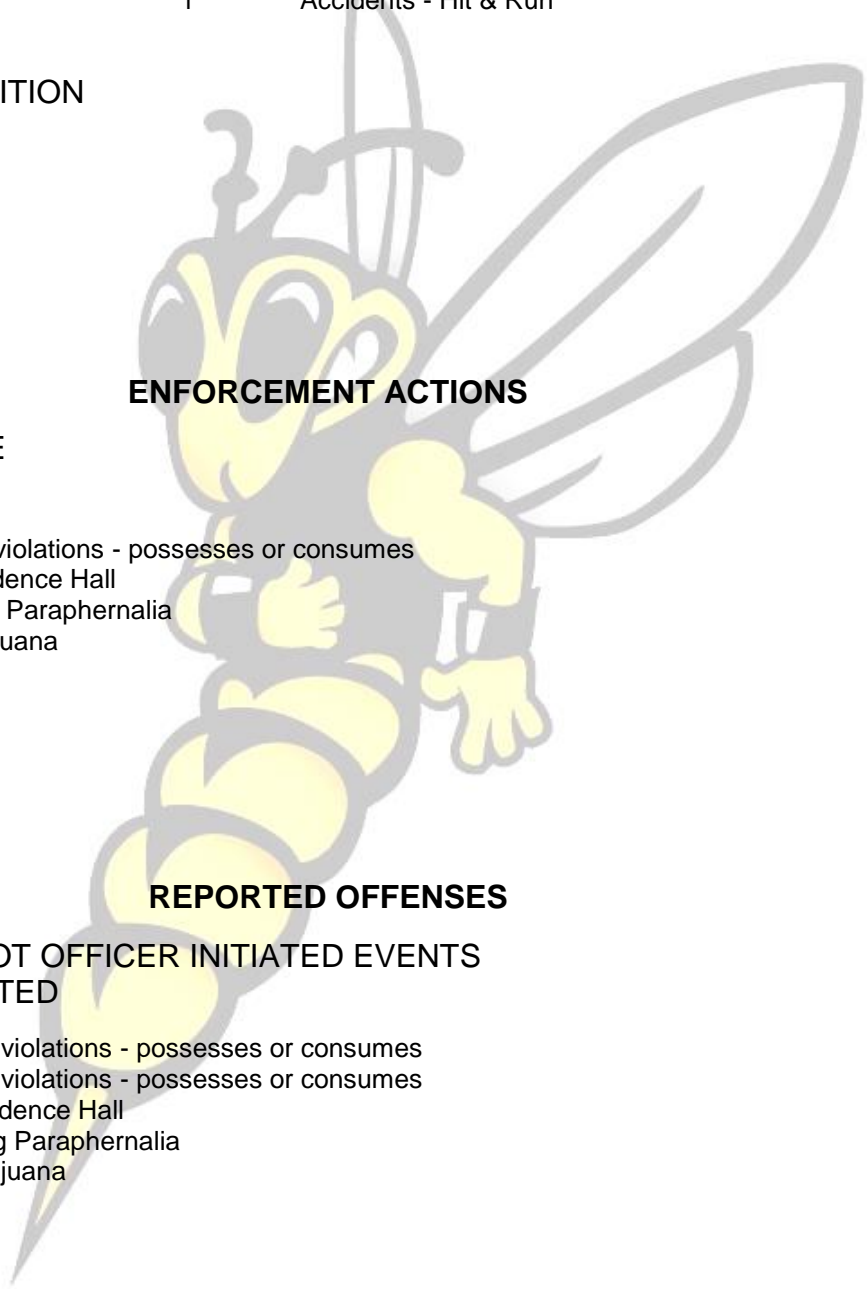

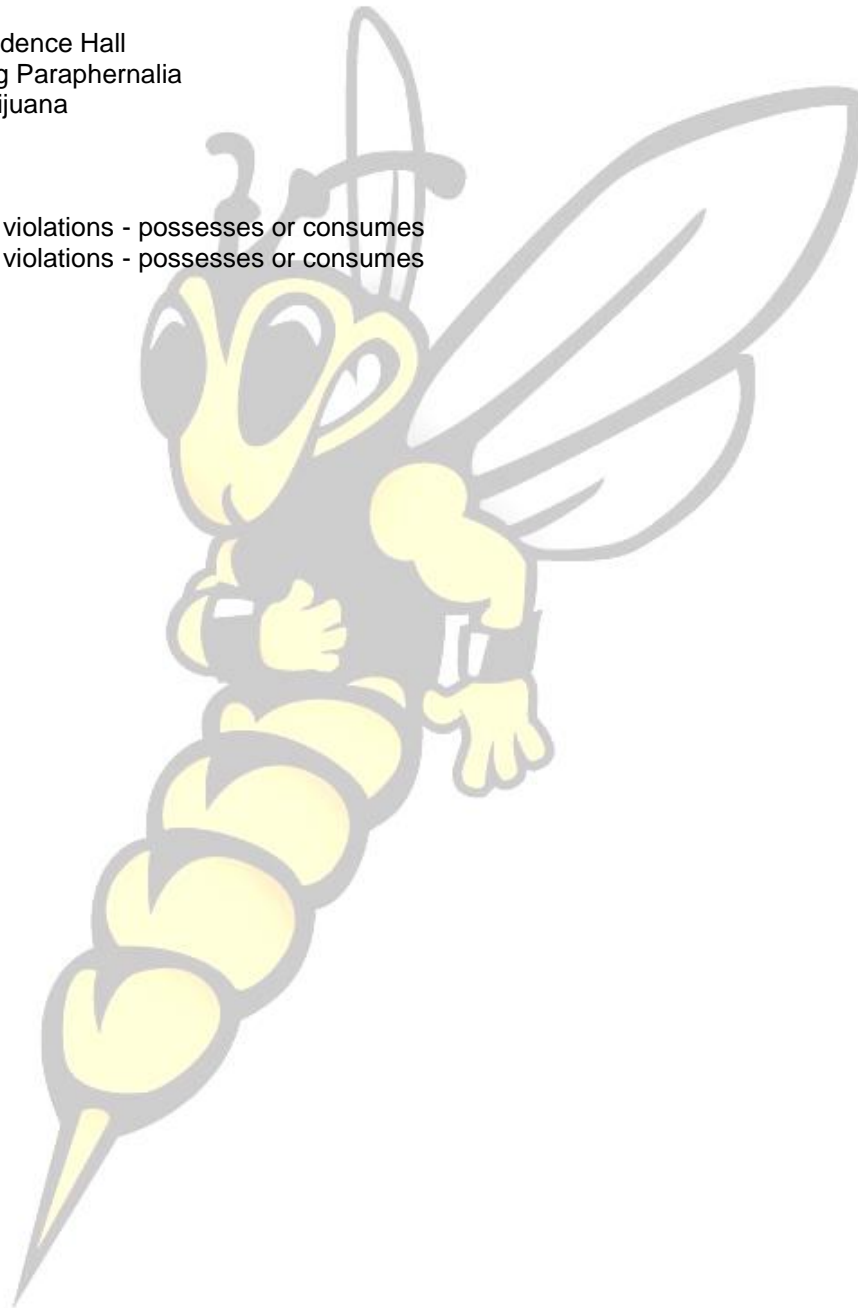

INCIDENT SUMMARY REPORT November 1 - 30, 2013

- Nov 2nd:** In Hawkes Hall, a female student was cited for Underage Drinking – second offense within one year, and is subject to a possible fine amount of \$389.50. Also, two female and one male student were all cited for Underage Drinking – first offense, and are all subject to a possible fine amount of \$263.50.
- Nov 5th:** A female student reported that her backpack may have been stolen from her parked vehicle on campus. Later on in the day her backpack was found in a classroom in Swenson Hall. This case was classified as unfounded.
