**INCIDENT SUMMARY REPORT
October 1 - 31, 2014**

Oct 2nd	In Ostrander Hall, a male student was cited for Underage Drinking or Possession, 2 nd offense within one year, after being seen carrying a case of beer. He is subject to a possible fine amount of \$389.50.
Oct 3rd	A Campus Safety Officer stopped to check on three individuals sitting in a “smoke-filled” vehicle in Lot# 6. A male student, who had been in the vehicle, was subsequently cited for Possession of Marijuana and Possession of Drug Paraphernalia and is subject to possible fine amounts of \$389.50 and \$326.50 respectively.
Oct 4th	Campus Safety received a call to check on a “loud room” in Ostrander Hall. As a result three male students and one female were all cited for Underage Drinking-First Offense, and are subject to possible fine amounts of \$263.50. Another male student was cited for Prohibited Procuring or Dispensing of Alcohol, and is subject to a possible fine amount of \$200.50.
Oct 5th	Campus Safety responded to a report of an ill female in Curran/McNeill Halls. The female student was ultimately transported by ambulance to Essentia Hospital in Duluth.
Oct 8th	A student reported that her truck, which had been parked in Lot# 3, had been struck by a hit/run vehicle sometime during the day.

	Another student, who had also been parked in Lot# 3, reported finding damage on the passenger side of his car. He did advise the damage could have occurred somewhere else but he had just noticed it.
Oct 11th	A Campus Safety Officer stopped to check on a male drinking from a can of beer outside of Ostrander Hall. The subject ran from the officer but was caught a short distance away. The student was subsequently cited for Underage Drinking-first offense, Possession of Marijuana, and Resisting Arrest. He is subject to possible fine amounts of \$263.50, \$260.00 and \$389.50 on the charges.
Oct 19th	A Campus Safety Officer stopped to check on two people in a "smoke filled" vehicle in Lot #3A. A male student was subsequently cited for Possession of Drug Paraphernalia and is subject to a possible fine amount of \$326.50.
Oct 24th	A female student reported that her roommate had allegedly used her credit card to make a small purchase without her permission. The student did not wish to press charges.
Oct 31st	A Custodian reported finding a vandalized cigarette butt receptacle outside the south Old Main entrance. Some scratches were noted on the entrance door which may be related.
