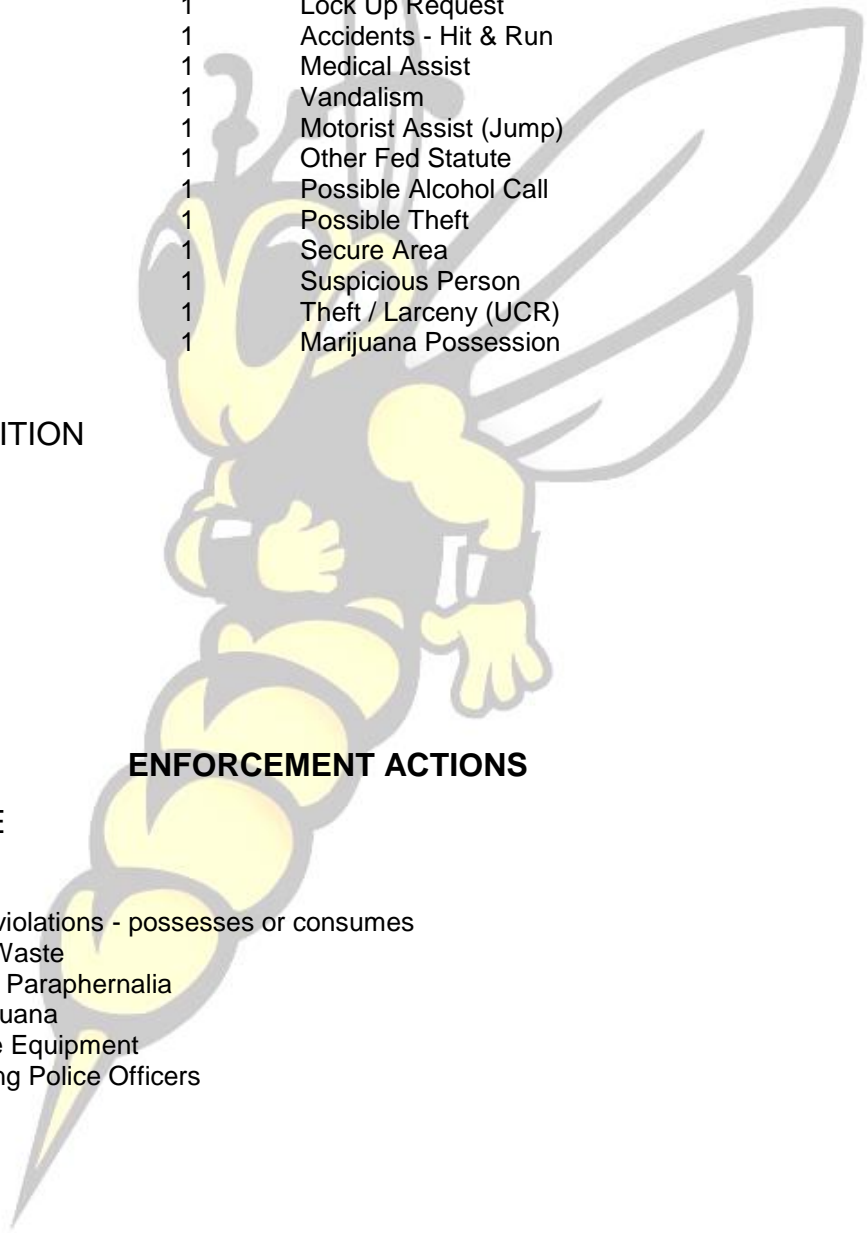

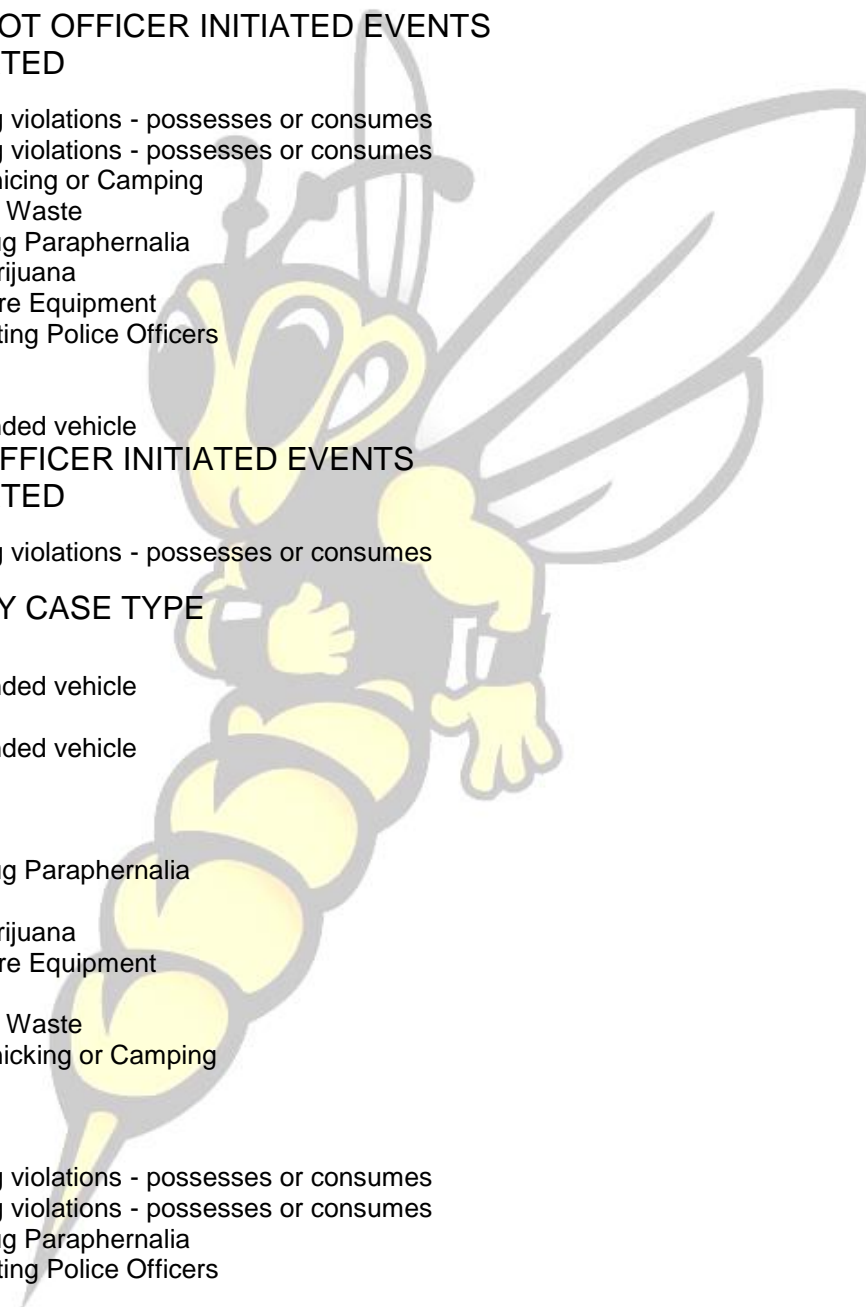

INCIDENT SUMMARY REPORT September 1 - 30, 2012

Sep 1st:

In Curran/McNeill Halls; A male student was cited for Underage Drinking, first offense, and is subject to a possible fine amount of \$268.50. He was also cited for Resisting an Officer, (Fleeing), and is subject to an additional fine amount of \$452.50.

In lot #3A; a female student was cited for Deposit of Human Waste and is subject to a possible fine amount of \$263.50.

Sep 2nd:

A student reported a broken window on the basement level of Ostrander Hall. Cause unknown at this time.

In Ostrander Hall; a male student was cited for Underage Possession of Alcohol, first offense, and is subject to a possible fine amount of \$263.50. He was also cited for Possession of Drug Paraphernalia and is subject to an additional fine amount of \$326.50.

Sep 8th:
